AN ORDINANCE TO AMEND CITY CODE SECTION 2-214.3
PROVIDING FOR THE ADOPTION OF SECTIONS OF THE
VIRGINIA PUBLIC PROCUREMENT ACT

Section Amended: 2-214.3

WHEREAS, 2025 Acts of Assembly c. 27 provides additional contractual protections for the City if § 2.2-4311.3 is adopted by the governing body as part of its incorporation by reference of the Virginia Public Procurement Act; and

WHEREAS, reassembling the list of sections incorporated by the City Code in the same order as such provisions occur in the Virginia Code will ease reading by residents and the business community;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF VIRGINIA BEACH, VIRGINIA, THAT:

1. Section 2-214.3 of the City Code is hereby amended and reordained to read as follows:

Sec. 2-214.3. – Adoption of designated sections of the Virginia Public Procurement Act.

(a) Pursuant to section 2.2-4302 of the Code of Virginia, as amended, the following sections of the Virginia Public Procurement Act [Code of Virginia, title 2.2, chapter 43], and any future amendments thereto, are hereby adopted and incorporated by reference into this code: 2.2-4301, 2.2-4302.1, 2.2-4302.2, 2.2-4343(B), 2.2-4304(A), 2.2-4303, 2.2-4303.1 through 2.2-4305, 2.2-4308.1 through 2.2-4310, 2.2-4311 through 2.2-4312, (including 2.2-4311.3), 2.2-4319, 2.2-4331, 2.2-4310(A), 2.2-4320, 2.2-4344(A)(1), 2.2-4309(B), 2.2-4344(A)(2), 2.2-4344(B), 2.2-4345(A)(13) and 2.2-4344(C), 2.2-4317, 2.2-4332, 2.2-4324, 2.2-4328, 2.2-4315 through 2.2-4321, 2.2-4323.1, 2.2-4324, 2.2-4328, and 2.2-4350(B), 2.2-4353, 2.2-4349, 2.2-4354 2.2-4329.1 through 2.2-4377.

(b) Notwithstanding subsection (a) of this section, whenever any provision of the Virginia Public Procurement Act which has been adopted and incorporated by reference herein is modified or amended by any other section of this code, or by any rule, regulation, policy, procedure or administrative directive, such provision shall be interpreted and implemented as modified or amended.

2. This ordinance shall be effective July 1, 2025.
